### **Working to Reunite Families:**

# Sonia was separated from her children and remains detained even though she won her case #FamiliesBelongTogether

The separation of families is not only happening at the border; there are families being separated by ICE every day all over the country.

Sonia Felix Castañon is a domestic violence and sexual assault survivor, and now a victim of this administration's family separation policy. Sonia has been in ICE detention for more than 11 months, separated from her four children, even though an immigration judge granted her the right to stay in the U.S. and a pathway to citizenship. Although ICE appealed the immigration judge's positive decision, Pangea and our community are asking for another bond hearing so that Sonia can be reunited with her family.

Sonia, her family, and the greater community have been motivated by the <u>tens of thousands who</u> mobilized and took to the streets for families like Sonia's!

## Policy Advocacy: Pangea community in Sacramento for Immigrant Day

This year, Pangea members and two Pangea clients traveled to Sacramento to advocate with our state legislators for immigrant rights in California. At a time when the federal administration is attacking our state for sanctuary and other immigrant friendly policies like <u>SB 54</u> and <u>AB 103</u>, it is all the more important for our community to stay strong and speak up. "I feel really moved and inspired being at my first Immigrant Day, fighting for our community. I think it's important to tell our stories so our elected officials can make more informed decisions," said Floricel Liborio Ramos, Pangea client.

### Trans client, Noelia, paroled from Stewart Detention Facility in Georgia

On the first day of Pride month, Pangea client, Noelia (pronouns they/them/their), was granted parole after 6 months in detention in Folkston and Lumpkin, Georgia. Detention facilities are unbearable for most human beings, and the Folkston and Stewart private prisons in Georgia are particularly atrocious, forcing individuals to self-deport to dangerous conditions <u>and even commit suicide</u>.

In an <u>interview that Noelia did with NBC News</u> a few days after their release, they discussed the horrific abuse that they experienced in ICE detention, highlighting the deplorable abuses against LGBTQ+ immigrants.

Pangea worked in partnership with the Southeast Immigrant Freedom Initiative (SIFI), a program

at the Southern Poverty Law Center. Attorney Marie Vincent successfully advocated with U.S. senators, who called and wrote letters in support of Noelia's release.

Luckily, Noelia's resilience and strength were greater than the oppression they suffered in ICE detention, and Noelia was able to attend San Francisco Pride on June 24!

## San Francisco High School Students Pressure Senator Kamala Harris and ICE to Release Teenage Afghan Boy from Adult Detention

<u>Pangea client, Hamid</u>, a 17-year-old Afghan boy fleeing violence by the Taliban and ISIS, spent nearly 6 months in adult immigration detention before he was released on an astronomically high ICE bond of \$25,000.

High school students in 415 Unidos for Freedom—a youth activist group run out of the June Jordan School for Equity in San Francisco—pressured Senator Kamala Harris's office to make a public statement in support of Hamid's release from ICE custody. After meeting with Sen. Harris' office, the students accompanied Sen. Harris' staff on a visit with Hamid at the Mesa Verde Detention Facility, where he was being held. After six long months for Hamid and one

short week after Sen. Harris' office got involved, ICE set a bond for Hamid.

Thanks to the students and generous community support from around the country, <u>Hamid was finally freed from adult detention on June 8, 2018</u>.
